Pupils and students over the age of 18 pay the youth fee with proof of schooling/certificate of enrolment. Without the appropriate proof, the full fee must be paid. If the certificate is not available in time, the switch to adult contribution will take place automatically.

The admission fee is 10.00 € for adults/adolescents/children. Contributions can only be paid by means of a direct debit procedure (see direct debit authorisation).
